APL 20-038 General Licensure Regulations Update: Knox-Keene licensure phase-in extended

As a courtesy, Aetna Health of California Inc. (Aetna) reminds the provider community assuming any amount of global risk to either obtain a license under the Knox-Keene Health Care Service Plan Act of 1975 (Knox-Keene Act) or an exemption from the DMHC for a contract subject to the General Licensure Regulation. Requirements are on the <u>DMHC website.</u>

The DMHC is extending the phase-in period until the General Licensure Regulation is amended. This will likely be late 2021 or early 2022. During this time entities may use the expedited exemption request process. For entities that have received an exemption, the DMHC is extending the duration of those orders. More information about the extension and expedited exemption process are in the All Plan Letter 20-038. You can find it on <u>the</u> <u>DMHC website</u>.

You should meet with your legal counsel to determine:

- If this applies to your organization, and
- The specific processes are followed to ensure compliance

## COVID-19 vaccine

Vaccines will be covered based on contractual arrangements for the administration of any COVID-19 vaccine that has received FDA authorization or emergency authorization. There will be no cost-share to our members. Currently, the federal government is covering the cost of the vaccine.

The administering provider must submit a clean claim toyour delegated groups/IPA for processing or if you are directly contracted with ABHCA, please promptly direct all claims to Aetna Better Health of California by mail or electronically.
