Dear Provider,

The purpose of this notice is to inform all providers that Aetna Better Health of Florida (ABHFL) has updated its claims processing systems to reflect the inpatient Diagnosis Related Group (DRG) rate changes adopted by the Legislature in SFY 2020-21 HB 5001.

DRG payment methods involve classifying inpatient stays and then determining a price based on a combination of the classification and the hospital where the services were performed. The classifications are labeled using codes referred to as DRG codes.

Please review the attached Diagnosis Related Group (DRG) Adjustment communication for details.

Diagnosis Related Group (DRG) Adjustments

Dear Provider,

As you know, the Agency for Health Care Administration (AHCA) recently updated its Diagnosis Related Group (DRG) Calculator to align with changes adopted by the Legislature in SFY 2020-21 HB 5001 back of the bill provisions. These changes were implemented effective May 1, 2020 and applied retrospectively to include inpatient claims with dates of service July 1, 2019 – April 30, 2020.

Aetna Better Health of Florida Inc. (ABHFL) has updated its claims processing systems to reflect the inpatient DRG rate changes posted to AHCA's website and has begun its adjustments to inpatient claims impacted by the DRG rate change. ABHFL will complete these adjustments no later than **September 1, 2020**.
