# Aetna Better Health® of Florida Medicaid Provider Minimum Wage Supplemental Wage Agreement

## Dear Provider,

Aetna Better Health of Florida (ABHFL) would like to inform you that as of June 2, 2022, Governor Ron DeSantis signed the Freedom First budget for State Fiscal Year (SFY) 2022-2023. The Freedom First Budget provided over \$600 million in funding to the Agency for Health Care Administration (Agency or AHCA) for the sole purpose of increasing the minimum wage for employees of Medicaid providers to at least \$15.00 an hour.

To distribute the funds appropriated for the Medicaid provider minimum wage requirement, AHCA has been directed to increase Medicaid managed care reimbursement rates and certain Medicaid fee-for-service fee schedules.

The funds appropriated to support the \$15.00 minimum wage will be applied to the Medicaid Fee-for-Service Fee Schedules are listed below. All fee schedules will be updated by October 1, 2022. The increases for Nursing Homes, Federally Qualified Health Centers and Rural Health Clinic rates will be effective October 1, 2022. All other Fee Schedule increases related to the minimum wage will be complete by October 1, 2022, and retroactively effective to July 1, 2022.
