# **P4P Extra Incentive Program Reminders**

A significant change to this year's program is that the rendering provider for Childhood Immunization by Age Two (Combo 3) will receive the incentive payment. A CIS incentive in the amount of \$10 will be paid to the rendering provider on a per-visit basis for Combo 3 immunizations (not for the completion of the Combo 3 series). Due to the need for catch up vaccines, the age range for the incentive has been extended to three years (36 months).

### **Bonus for Early Completion**

Only a few weeks are left to qualify for the 2021 "Front-Loaded Performance Incentive." To encourage timely completion of important services, several measures are included in the program. This bonus will add 50% to payments for eligible measures. Gaps must be closed with a date of service on or before August 31, 2021. Measures eligible for this bonus are detailed in the table below.

- Select Business Intelligence Reports Application
- Pick Organization, Tax ID, and NPI, and wait for Provider QNXT ID to auto-generate. Then click Submit.
- Within the Business Intelligence Reports portal, click on Value Based Solutions menu to access the P4Q.
- Select P4Q Performance Report.
- Use the pulldown menu next to the floppy disk icon to select format for download.
