

Supplemental Data Exchange (SDS)

Aetna Better Health[®] of Illinois seeks to enhance data sharing with our network providers. Timely data is key to reporting and documenting HEDIS[®] services provided to our members.

A Supplemental Data Exchange (SDS) allows HEDIS[®] data to be transmitted directly to our plan through a streamlined process.

Providers can now set up an SDS directly with Aetna Better Health of Illinois to simplify data exchange and meet pay-for-performance (P4P) goals.

SDS increases your opportunity to earn P4P dollars by:

- Reducing reliability on non-billable codes to account for HEDIS services
- Submitting HEDIS data at your desired frequency
- Reducing the need for medical record review to confirm closure of HEDIS care gaps.
- Driving appropriate, high quality patient care through a fast and efficient exchange of information with your health care partners

New for 2023

Providers with more than a thousand members will receive a one-time bonus of \$1,000 for a new SDS approved by September 1, 2023.

What's needed?

- 1. All documentation approved/submitted prior to 9/1/2023 for MY2023 data
- 2. Managed File Transfer (MFT) Form: needed to set up a secure file transfer protocol (SFTP)
- 3. Supplemental Data Source Requirement Document: information about the provider and data
- 4. Medicaid Supplemental Data Layouts: required layout for data feeds

How does it work?

- ✓ Complete an MFT form to identify your organization contacts and file frequency.
- ✓ Your Quality Practice Liaison (QPL) will arrange a meeting with your IT team to discuss your goals and answer questions.
- ✓ The SFTP/FTP site will be developed for a sample file to be sent to Aetna® by your IT team.
- \checkmark Select the file layout that best fits the type of data to be shared. There are two formats:
 - o lab data (example: immunization, A1c values, etc.)
 - service file data (example: screenings, well-child visits, etc.)
- \checkmark Populate the required fields for your target measures.
- ✓ Deliver electronic data files via secure file transfer or secure email based on your desired frequency.
- ✓ Earn incentive dollars for meeting P4P targets.
