The request should be submitted in writing with accompanying medical documentation. You may also submit the documentation via fax to the Appeals Department at **1-855-454-5585**.

If you have a request for services that is not associated with a claims denial, you may submit the request with all clinical documentation to the Retrospective Review Department at 855-336-6054. Be sure to include any extenuation circumstances or any reason for the late request.
