In the News: 1. Crossover Claim Edit for Medicare Crossover forms, effective March 10, 2017

1. Earlier this week you may have received notice of this cross over claim edit. This fax blast is to inform you that we are moving back the effective date of this Medicare Crossover edit. **We will not implement on February 24, 2017**, as originally stated..

We will implement the new claim processing edit as of **March 10, 2017,** to only allow Medicare Crossover forms from those Provider Types specified by DMS. Denial examples include, but are not limited to: Provider Type 44 (Hospice) billing on a UB Crossover, Provider Type 32 (Family Planning) billing on a HCFA Crossover. Please see the following chart for the full list provider types.
