Dear Aetna Better Health Partners:

We value your feedback with regard to our policies and opportunities for enhanced partnership. As a result, effective **November 1, 2019** Aetna Better Health of Kentucky will no longer require prior authorizations for the first obstetric ultrasound (see CPT listed below) in the first trimester and the first obstetric ultrasound in the second or third trimester per Aetna enrollee.

Aetna Better Health of Kentucky will allow one standard **first trimester** ultrasound (CPT code **76801**) per pregnancy without requiring prior authorization. Prior authorization is required for subsequent **first trimester** ultrasounds.

Aetna Better Health of Kentucky will also allow one standard **second or third trimester** ultrasound (**76805**) per pregnancy without requiring prior authorization. Aetna Better Health will also allow CPT code **76810** without a prior authorization when billed with CPT **76805** as the primary code. Prior authorization is required for subsequent **second or third trimester** ultrasounds.
