## Intensive Outpatient Program (IOP) Covered Services & Requirements

Aetna Better Health of Kentucky would like to remind providers about the regulatory requirements for coverage and reimbursement of IOP (H0015/S9480) services.

- An Intensive outpatient program (IOP) is an alternative to or transition from inpatient hospitalization or partial hospitalization from mental health and/or substance abuse disorders.
- An IOP must offer a **multi-modal, multi-disciplinary** structured outpatient treatment program that is significantly more intense than individual, group, and family therapies.
- IOP services must be provided at least three (3) hours per day and at least three (3) days per week for adults, and at least six (6) hours per week for adolescents.
- **Programming must include** individual, group, and family therapy unless contraindicated, crisis intervention as it would occur in the setting where IOP is being provided, and psychoeducation. These services should be available to the recipients according to their individualized treatment plans.

**To provide Intensive Outpatient Program services**, a provider must be employed by a behavioral health multi-specialty group, CMHC, CCBHC, or behavioral health provider group.

In addition, to provide IOP the provider group must have:

- Access to a board-certified or board-eligible psychiatrist for consultation.
- Access to a **psychiatrist, other physician, or advanced practice registered nurse** for medication management.

What does "access to" mean? "Access to" means that the provider group must have a contract with those providers.
