Attention: Ensuring best practices in clinical record keeping (charting).

Following some recent chart audits, Aetna Better Health of Louisiana® is issuing this communication to ensure best practices in clinical documentation in the medical record in support of reimbursement.

Charting Recommendations:

- 1. Each service entry should include a start and end time. Do not rely exclusively on the electronic record (and the programmed CPT code) to document session length.
- 2. Each service entry should contain substantial clinical content.
 - a. avoid vague, generic phrasing, and
 - b. avoid copy-and-paste repetitive notes
- 3. Utilize a structured note (instead of narrative note) format to assist with # 2 above. Some options include:
 - a) SOAP = Subjective data, O = Objective data, A = Assessment, P = Plan
 - b) DAP =Data (Objective and Subjective), A = Assessment, P = Plan
 - c) BIRP = Behavior, I = Intervention, R= Response, P = Plan

Clinical content should at a minimum address the following:

- An observation of Client's behavior.
- The goals/objectives identified to be worked on during the session.
- The interventions utilized during the session to reach goals/objectives.
