Social Determinants of Health (SDoH) Incentive: SYSTEM UPDATE COMPLETE - G9919 Code Termination

ABHLA has completed the necessary system configurations required for the use of HCPCS code G0136 for SDoH screening in place of the terminated code G9919. Previously submitted claims impacted by the code switch are being recycled. Providers will begin receiving claims payments beginning next week.

We thank you for your understanding and ask for your continued patience as we continue to work through this issue.

For your reference, the original notification outlining the code termination and resulting action is outlined below. This notification was distributed January 30, 2025.

-ORIGINAL NOTIFICATION-

Effective 12/31/2024, the Centers for Medicare and Medicaid Services has terminated HCPCS code G9919. This update has resulted in unintended claims denials and/or improper reimbursement for the reporting of SDoH screenings.

For dates of service (DOS) on or after 01/01/2025, providers performing SDoH screenings who would have billed code G9919 should utilize HCPCS code **G0136** (ADMINISTRATION OF A STANDARDIZED, EV) in conjunction with the appropriate diagnosis (Z) code.

Providers who submitted claims containing code G9919 and received an incorrect denial or improper payment beginning DOS 01/01/25 will need to resubmit with the new billing practice. Claims billed with G0136 and the appropriate Z code beginning DOS 01/01/25 will receive the professional fee payment; once our system is updated to reflect the change, these claims will be automatically recycled for reimbursement of the proper rate. Please allow 30 days for this update to take effect.

G0136 billed independently will pay at the professional fee schedule rate on file with LDH. G0136 billed alongside one of the below Z code classes will pay the SDoH incentive rate:
