SUBJECT: Nursing Facility Infection Prevention and Control Enhancement Grants

Application

Dear Provider,

We received news from the Michigan Department of Health and Human Services (MDHHS) that it is making available to Medicaid-certified nursing facilities *Infection Control Enhancement Grants*. The purpose of these grants is to support permanent improvements to a facility's equipment to achieve more effective infection prevention and control. Infection prevention and control was an area of concern prior to the pandemic, and the pandemic underscores how important it is to make lasting improvements in nursing facilities. These grants can be used to pay for all or a portion of the costs of infection control equipment.

Timeline

The grants are made possible through federal COVID Relief Funds. **Facilities must spend the funds by December 31, 2020.** For example, if the funds are to be used to purchase and install equipment, the installation must be completed by December 31, 2020. Or, if the funds are to be used to purchase the equipment and other funds used to pay for installation, the equipment must be purchased by December 31, 2020.

Applications may be submitted until 5:00 pm, October 31, 2020. MDHHS will review all applications for completeness. MDHHS and the Department of Licensing and Regulatory Affairs (LARA) will review all complete applications to assure the review criteria defined below are met. The facility will be notified of the grant determination within ten business days of submission of the application. Payment will be made through a gross adjustment within two weeks of approval.

The nursing facility must submit documentation of the expenditure of grant funds to MDHHS by February 1, 2021. If the documentation does not demonstrate that the funds were spent by December 31, 2020, MDHHS will recover the amount of the award.

Grant Amount

MDHHS has established two award amounts:

- Nursing facilities in high poverty areas: up to \$22,000
- Nursing facilities not in high poverty areas: up to \$18,500

High poverty areas are defined as areas of the state where at least 20% of the population is living below the poverty level, based upon the Area Deprivation Index (ADI). The ADI is a multidimensional evaluation of a region's socioeconomic conditions, which have been linked to health outcomes. A listing of nursing facilities in high poverty areas is included as Appendix A to this document.

Examples of Infection Control Equipment

This list is not exhaustive, and some items may not be appropriate for certain physical plant conditions.

- Energy recovery unit
- Portable UVC unit
- HEPA filters
- HVAC retrofit to accommodate higher efficiency filters
- Upgraded exhaust fan system
- Physical plant enhancements for visitation rooms
- Electrostatic fogger with bacteriostatic/viricidal cleaner
- Photo-catalytic oxidation (PCO) units
- Touchless hand sanitation dispensers
- Touchless forehead temperature scanners

Grant funds may not be used to replenish infection control supplies used in normal operations including but not limited to personal protective equipment and cleaning supplies. For example, if the application includes touchless hand sanitation dispensers, it may also include the sanitizer used in the dispensers. However, if an application does not include dispensers, it could not include sanitizer to refill the current dispensers.

Review Criteria

The application may include the cost of a technical evaluation to determine the facility needs, the infection control equipment, installation, and supplies, if needed by the equipment. The review criteria are as follows:

- 1. The application must be complete. Incomplete applications will be returned to the facility and may be resubmitted. The corrected application must be submitted within 5 business days of notification by MDHHS.
- 2. The equipment must be designed to improve infection control in a healthcare setting.
- 3. The equipment must be appropriate to meet the stated need in the setting where it will be used.
- 4. The purchase and installation (if funded by the grant) must be feasible by December 31, 2020.
