CMS has Approved HHSC's Request to Delay the EVV Start Date

<u>HHSC's request to delay</u> the Jan. 1, 2020 electronic visit verification start date for the programs, services, and service delivery options affected by 21st Century Cures Act is approved.

HHSC already requires EVV for about 90 percent of personal care services. This delay allows more time to address EVV implementation challenges for the remaining personal care programs and services. See the full list of delayed programs, services, and service delivery options in the table below.

Providers currently required to use EVV must continue to use EVV under state law and HHSC policy. See the <u>Programs and Services Currently Required to Use</u> <u>Electronic Visit Verification</u> on page 3.
