

# Electronic Visit Verification Cures Act EVV Training Requirements Checklists

Revised July 9, 2020

This document provides training checklists for program providers, financial management services agencies (FMSAs), consumer directed services (CDS) employers, CDS employees, and service attendants affected by the <a href="Cures Act EVV Expansion">Cures Act EVV Expansion</a>.

Program providers currently required to use EVV by state law should refer to the <u>Existing</u> <u>Provider EVV Checklist</u> for their training requirements. To confirm <u>EVV-required services by program</u>, refer to pages 1-2 for Cures Act, and pages 3-4 for Existing EVV.

Program providers and FMSAs must keep up-to-date records of training completion for all users of the EVV system because HHSC or a managed care organization (MCO) may request proof of completed training. Do not submit proof of training completion to HHSC, an MCO, or TMHP, unless requested. For more information about training requirements, refer to the Health and Human Services Commission (HHSC) EVV Training Policy.
