

Osteoporosis Management in Women Who Had a Fracture (OMW)

Women ages 67–85

MEDICARE

Measure definition

Women who had a fracture **and** either a bone mineral density (BMD) test **or** received a prescription to treat osteoporosis within 6 months of fracture (excludes fractures to the phalanges (fingers/toes), face and skull)

Intake period: From July 1 of year prior to measurement year to June 30 of measurement year

- The intake period is used to capture the first fracture

Remove episode dates where any of the following are met:

- Members who had a BMD test during 24 months prior to fracture
- Members who had a claim **or** encounter for osteoporosis therapy within 365 days prior to fracture
- Members who received a dispensed prescription **or** had an active prescription to treat osteoporosis within 365 days prior to episode date



Medical record requirements

- Member legal name and date of birth
- Provider/practice identifier
- Provider Business Group (PBG) name and number
- Date of service (DOS)
- Applicable lab/test results and date collected



Commonly used claim codes*

- BMD test: **77080, 77081, 77085**
- Osteoporosis medication therapy:
- Injection, denosumab, 1 mg: **J0897**
 - Injection, ibandronate sodium, 1 mg: **J1740**
 - Injection, teriparatide, 10 mcg: **J3110**
 - Injection, romosozumab-aqqg, 1 mg: **J3111**
 - Injection, zoledronic acid, 1 mg: **J3489**

Medical record submission methods may not be applicable to all plan types.

Required exclusions (Other exclusions may also apply)

- Members in hospice or using hospice services during measurement year
- Members who died anytime during measurement year
- Members who had a palliative care encounter **or** received palliative care anytime during intake period through end of measurement year
- Members ages 67 and older as of December 31 of measurement year who meet **either** of the following:
 - Enrolled in an Institutional SNP (I-SNP) anytime during the intake period through the end of the measurement year
 - Living long-term in an institution anytime during the intake period through end of measurement year
- Members 67–80 years of age and older by the end of the measurement year with **both** frailty **and** advanced illness. Members **must** meet **both** frailty and advanced illness criteria to be excluded:
 - For frailty, at least 2 indications of frailty with different dates of service during the intake period through the end of measurement year
 - For advanced illness, either of the following during the measurement year **or** year prior:
 - Advanced illness on at least 2 different dates of service
 - Dispensed dementia medication
- Members ages 81 and older as of December 31 of measurement year with at least 2 indications of frailty during the intake period through the end of measurement year

Insights and recommendations

- Order a BMD test on all women with a diagnosis of a fracture **or** prescribe medication to prevent osteoporosis within 6 months.
- Schedule a follow-up to review BMD results **and/or** medication adherence.
- Ensure accurate coding of fractures.
- Let members know pharmacists can be a resource for questions about medications.
- Keep in mind that BMD testing in an inpatient setting satisfies this measure.
