Postpartum Incentive (PPC Postpartum)	\$75 per eligible claim	<ul style="list-style-type: none"> · Claim with a Date of Service 7-84 days post-delivery must be billed with CPT code 59430 · Payments will be made quarterly
Members 3-21 (Well Care/WCV)	\$25 per eligible claim	<ul style="list-style-type: none"> · Claim must be billed with a valid well care exam CPT code by the provider/group the Gaps in Care Report was sent to · Payments will be made quarterly
Diabetic Eye Exam Incentive (EED)	\$25 per eligible claim	<ul style="list-style-type: none"> · Claim must be billed with a valid CPT code by the provider/group the Gaps in Care Report was sent to · Payments will be made quarterly

WHO'S ELIGIBLE	REWARD	ACTION
Members 3-21 (Well Care Visit)	\$25 Gift Card	Have a well care exam completed during the calendar year (WCV)
Members who attend Aetna sponsored wellness event *Wellness events can be designed in the areas of: well woman, diabetes, dental, and well-child.	\$25 Gift Card	Have screening completed (Examples – Pap smear, mammogram, dental visit, diabetes labs, diabetic eye exam, well-child visits)
Adolescent members 13 years of age	\$25 gift Card	Complete HPV series, Tdap, and Meningococcal by the 13 th birthday. (IMA Combo 2)
Children that turn 2 years of age	\$25 Gift Card	Complete DTaP, IPV, MMR, Hib, Hep B, VZV, PCV, Hep A, Rotavirus, and Influenza vaccines (CIS Combo 10)
Members with Diabetes **Select counties only	\$25 Gift Card	Enroll in an approved diabetic education program and complete classes/HbA1c testing.
Members with Diabetes	\$25 Gift Card	Complete diabetic eye exam. (EED)
Pregnant members (Prenatal Care)	Pack-N-Play	6 or more prenatal visits. (PPC Prenatal)
Pregnant members (Postpartum Care)	\$50 Gift Card	Postpartum visit completed within 7-84 days after delivery (PPC Postpartum)
Pregnant members with substance use disorder during pregnancy (Prenatal and Postpartum Care)	Baby Carrier or Pack N Play Child's Push Toy	Mother and baby must successfully complete the Neonatal Abstinence Syndrome (NAS) Program through Case Management.
Adult members 18 and over	\$25 Gift Card	Adult 8-Week Walking Program-Members receive a pedometer and log for tracking steps and receive a gift card upon completion.
Members with Congestive Heart Failure	Weight Scales	Enroll and participate in Case Management.
Members 6 and older (Follow Up After Hospitalization)	\$25 Gift Card	Complete visit within 7 days after d/c from inpatient facility (dx of mental illness) (FUH)
The Ted E. Bear, M.D. Cub Club Children 13 and under	Various prizes Unique to each activity/challenge	Complete challenges to earn prizes upon completion. Focus is on prevention, healthy behaviors and wellness. (Examples – Immunizations, healthy eating, physical activity, dental care)
Adult members 18 and older	State Park Gift Card	Receive a flu shot.

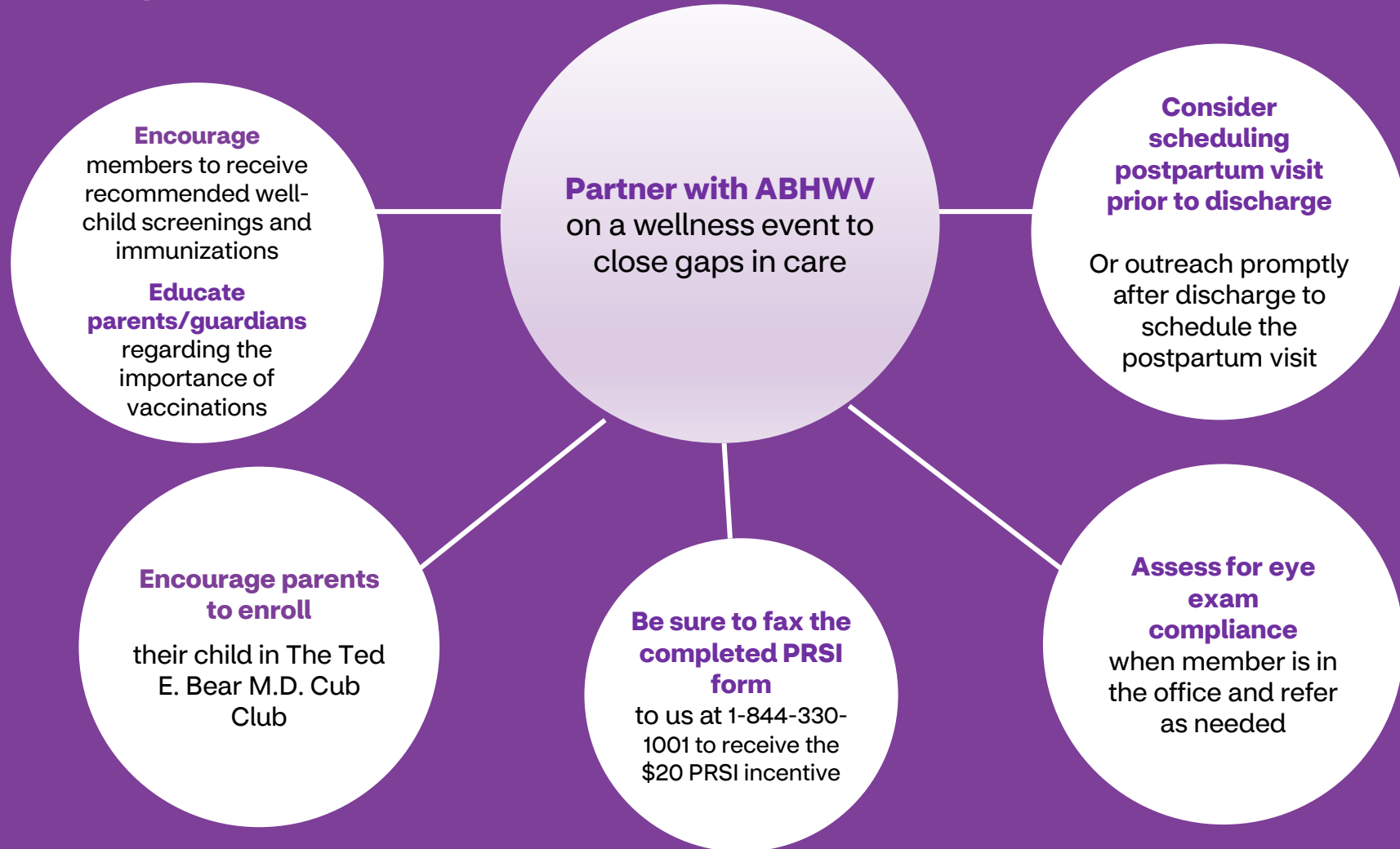
